The Industrial Safety Training Council (ISTC) and the Golden Triangle Business Roundtable (GTBR) are proud to announce the launch of a unified Contractor Safety Awards program for 2026.

For the first time, ISTC and GTBR have combined their longstanding safety recognition efforts into one comprehensive awards program. This joint initiative reflects our shared commitment to promoting contractor safety and accident prevention within the petroleum, refining, petrochemical manufacturing, and related industries across Southeast Texas.

By aligning our programs, we are creating a streamlined application process while continuing to uphold the high standards of excellence both organizations have championed for decades.


Award recipients will be honored at the 2026 Contractor Safety Awards Banquet, held at the Beaumont Civic Center. Doors will open at 9:00 a.m. for the Expo portion of the event, and the Awards Banquet will begin promptly at 11:00 a.m.

The following pages contain complete information regarding eligibility, award categories, and submission requirements. The deadline for submitting applications and required company information is May 4, 2026.

To support participants during this inaugural unified year, a Contractor Safety Awards Workshop will be held on April 16, 2026, from 9:00 a.m. to 3:00 p.m. This workshop is open to all contractors and will provide guidance and answer any questions related to the application process.

We encourage all eligible contractors to participate in this important regional recognition program as we celebrate safety performance across Southeast Texas.

Through a joint partnership, the Golden Triangle Business Roundtable (GTBR) and the Industrial Safety Training Council (ISTC) celebrate contractor safety leadership across Southeast Texas through a unified regional awards event. This program recognizes organizations and individuals who demonstrate a sustained commitment to safety excellence, strong safety culture, and outstanding field performance.

Recognition is organized into two award pillars designed to honor both long-term achievement and competitive, site-nominated performance.

#### Award Pillars:

Foundation of Safety Excellence - A contract company may apply for awards in as many categories as it qualifies.

- The Safety Achievement Award – Sustained Performance – recipients must achieve a “zero” recordable incidence rate for three consecutive years.
- Safety Legacy Award - Hours Worked - recipients must have worked 1,000,000 or more employee hours without a lost workday case involving days away from work or fatality.
- The Roy Comeaux Safety Champion of the Year Award – this award will recognize an outstanding safety professional who has contributed to the success of a company’s safety program and has received outstanding recognition.

Safety Performance Honors – A contractor must be nominated by local owner sites for exceptional safety performance in the field.

- Owner Tribute Award Recognition: Those companies who were nominated by a site. Recognized as one of the top performers at each site based on their criteria. Each company is divided into one of the following categories:
  - Maintenance and Construction: Small / Medium / Large
  - Specialty and Engineering: Small / Medium / Large
- Most Decorated Winner: Given to the companies in each man-hour category that received the highest number of nominations.
- Paramount Performance: Honor the top 25% in each category. The determination of these recipients is based on composite scores from the finalists OSHA safety metrics, GTBR award application and safety records.
- Donald T. Boumans Pinnacle Awards: The premiere safety award presented to the highest scoring contracting companies. Finalists sit for interviews with the Facility Safety Team. One award winner in Maintenance/Construction and one award in Specialty /Engineering for the award season.

All applications MUST be for work performed in the **Calcasieu Parish, LA, Orange County, Jefferson County, Chambers County, Baytown area.**

All applications MUST be accompanied by supporting documents as requested on the application.

All applications MUST be accompanied by the GTBR Safety Survey.

To be recognized for Safety Performance Honors, contractor companies must be nominated by a participating Owner Facility.

Application Deadline: May 4, 2026.

Please note that if you qualify for an award(s), you must complete the appropriate application form(s) and return it to ISTC & GTBR as soon as possible, but no later than May 4, 2026. Compliance with this requirement will ensure accurate processing of award applications in time for the presentation at the Awards Banquet held on August 20, 2026. Please return all applications for awards on the ISTC or GTBR website form submission.
